

COVID-19 STEWARDS

We have employed 16 COVID-19 stewards to support businesses and the public in increasing understanding of COVID-19 public health measures, such as social distancing, wearing face coverings in appropriate settings and hand washing.



The stewards will undertake patrols across Central Bedfordshire to engage, explain and encourage best practice and promote the national guidance around COVID-19.

The stewards have no enforcement powers, but they will gather intelligence and information on potential COVID-19 regulation breaches and feedback to the relevant officers in the Council to support further investigation and possible enforcement. They will also report incidents to Bedfordshire Police.

The new stewards, who will work from 9am to 9pm seven days a week, will be undertaking visits in Biggleswade, Sandy, Leighton Buzzard, Dunstable, Ampthill, Flitwick, Shefford and Houghton Regis. They will be wearing video cameras on their bodies and high visibility jackets to identify them as Council COVID-19 stewards.

Officers from our public protection and community safety teams will also be continuing to undertake regular patrols and visits to businesses across the whole of Central Bedfordshire, to ensure everyone is adhering to government guidelines and offering advice and support where needed.

The stewards will be provided through a contract with CYS Security Ltd and have been hired initially for 12 weeks, starting from 11 January 2021.

Anyone who has concerns about businesses not complying with the measures set out, should email trading.standards@centralbedfordshire.gov.uk with the subject 'COVID Business Compliance'. Reports will then be investigated by the appropriately delegated officers.

2. LEISURE, LIBRARIES & COUNTRYSIDE

HOUGHTON REGIS CHALK PIT UPDATE

BACKGROUND

Houghton Regis Chalk Pit is a privately owned site and with the exception of Footpath 1 there is no official public right of way.

Under the terms of a licence agreement with the site owners, the Wildlife Trust managed the site with funding provided via a S106 agreement. The conditions required the production of a management plan which was developed by the Trust and approved by Natural England as the quarry is part SSSI (Site of Special Scientific Interest).

The S106 made provision for payment of a commuted sum to the Wildlife Trust for the implementation of the plan and the cost of employing a management officer, full time, for the site, from autumn 2011 to spring 2017. The small amount left over was used by the Wildlife Trust, initially to continue the management of invasive scrub in the base of the quarry and more recently to cover the costs of litter removal. As the Trust no longer has any formal engagement with the quarry, the additional works were agreed with the owners separately.



FUTURE MANAGEMENT

The Council is now in receipt of the first tranche of new S106 funds to support the maintenance of the site. As HRN2 is developed further this will trigger additional payments until the full quarry maintenance contribution of £1,016,000 is reached.

Initial discussions with the Wildlife Trust have indicated that they would be interested in managing the site again although understandably this will be subject to agreement on terms. This includes a renewal of the licence agreement between the owners and the Trust to occupy the site plus a funding agreement between the Council and the Trust.

In the short term the Wildlife Trust and the Council will arrange for a preliminary site visit to assess the visual condition of the site and consider the work needed in order to develop a new management plan for approval by Natural England.

The Wildlife Trust will need to identify the resource needed for this work which in the current climate may be challenging but once allocated this will start the preliminary work needed in order to commence longer term management of the site.

HOUGHTON REGIS LEISURE CENTRE

In the week before Christmas, Bedfordshire was moved into tier four restrictions affecting some of the centre activities, but before this was even settled the government announced the closure of all leisure facilities from Saturday 19th December.

The building is now being managed in a way that will enable prompt and safe re-opening when allowed.

Centre Activity - 12 days of Christmas December gym challenge

The centre launched its December fitness challenge aimed at getting customers more active prior to Christmas and 40 customers had signed up to the challenge. Unfortunately, the Challenge could not be completed but did show that members still have an appetite for challenging their own fitness goals!

HOUGHTON REGIS LIBRARY

LIBRARY OPENING

We had a higher use of the service until Lockdown was announced. Houghton Regis Library is now open 09:30-18:00 Tuesday to Friday and 09:00-16:00 operating the Select and Collect service throughout the December Lockdown as well as through the changes in tiers and into our current Lockdown and have had some very encouraging comments from service users.

SUMMER READING CHALLENGE

The Reading Agency will release their theme title for this years summer reading challenge around Easter along with the official title. We have begun planning activities that can be delivered both in Houghton Regis Library and online through our social media, how we deliver these will be decided as we approach the last school term of the academic year.

COMMUNITY PHYSICAL ACTIVITY PROGRAMME - Currently suspended due to National lockdown

HOUGHTON HALL PARK

LOOKING BACK

We achieved:

- A hugely popular festive wreath making event with click and collect wreath packs and an online video to demonstrate how to create the wreaths.
- A festive display in the front of the kitchen garden with charismatic stick men which were created by park volunteers. The stick men were later sold to the public and very well-liked by local families.

Key highlights:

- Eleanor Evans has settled into the team fantastically in the role of Community Park Ranger.
- Despite the café and visitor centre being closed, a mobile coffee van has proven very popular with park users with highly positive feedback.

Key issues:

• One large event 'The Spirit of Christmas' was cancelled two days prior to the sold out activity due to being moved into Tier 3.

LOOKING FORWARD

We are planning:

- A range of new volunteering opportunities in the park led by the Community Park Ranger to increase scope for involvement by the community.
- Events programme to continue with Covid secure activities such as self-guided trails.
- A produce stall in the kitchen garden to facilitate the sale of plants, vegetables and flowers grown on site.



3. HIGHWAYS & TRANSPORT

WORKS COMPLETED

From 1st Oct - 21st December

276 visits were made to Houghton Regis and 28 Penalty Charge Notices have been issued.

4. BUSINESS, INVESTMENT & SKILLS

The team continue to engage with Central Bedfordshire's key employers through our business engagement programme to gather intelligence on the impact of the current situation, in addition we have been identifying businesses that are making redundancies and offering our help through the National Careers Service by offering support with CV writing, Online Job Searching, Application Forms and Interview Techniques.

We have also been responding to the recent business grant enquiries and have been signposting them to government business support packages and working with our Revenue and Benefits team to support businesses to help claim the different grants available to them.

BUSINESS SUPPORT GRANTS UPDATE

New business grant - the government has given us details of a new one-off grant for retail and hospitality businesses of up to £9,000 called the Closed Businesses Lockdown Payment (CBLP). The good news is that businesses will not have to make a fresh application to us. However, some businesses will be required to certify they were trading on Monday, 4 January 2021. We will be emailing asking them to confirm this so please monitor your email. We will not ask for bank details as we already hold this information.

Businesses eligible for CBLP will also be supported by a further payment of up to £4,500 under the Local Restrictions Support Grant, depending on rateable value. This is intended to cover the period up to and including Friday, 12 February 2021.

Businesses closed under Tier 4 - we are also contacting businesses that were required to close from Saturday, 19 December by email so we can make payments under the Tier 4 grant scheme. We will then make a payment to these businesses to cover the period up to and including Friday, 12 February 2021. No fresh application will be required while these businesses are obliged to remain closed. Businesses required to close under Tier 4 will automatically receive their one-off CBLP payment of up to £9,000 provided they have responded to our email confirming that they were trading when those restrictions came into force.



Commercial property enquiries - Houghton Regis/Dunstable (October - December 2020)

There were a total of 27 new property enquiries across Central Bedfordshire, 12 of which were interested in Houghton Regis/Dunstable – please see table below. The conversion of enquiry to commitment can take up to a year to come to fruition. But the team will look to add information to future reports.

BEDFORDSHIRE EMPLOYMENT & SKILLS SERVICE (BESS)

As with other Further Education providers, the Council's Employment and Skills Service (BESS) continues to deliver educational courses via its in-house delivery teams and a range of external training providers working as part of the BESS partnership.

Currently in this 2020/21 academic year, we have engaged with 46 Houghton Regis residents, despite the Covid-19 restrictions. The most popular courses have been Getting Started with English and Maths, Early Years and Supporting Teaching and Learning. The figures also include five individuals undertaking apprenticeships.

Enrolments will continue throughout the academic year, at the moment the majority will be online. A number of the programmes we offer are accredited, so residents can work towards qualifications which will help them gain employment, support a career change or help residents progress in their specific sectors. Other courses are non-accredited which means that whilst successful learners won't get a recognized qualification, their appetite for learning may have been inspired or they have learned how to progress on a particular career path and are better informed as to the direction they wish to go in.

In November 2020 the vacancy rate for all units within towns surveyed was 7.3%. This is an increase from the 7% reported for August 2019. SCHOOL ADMISSIONS

The closing date Starting school and transfer to Middle school applications is 15th January 2021.

For Transfer to Secondary and Upper school 2021 the closing date has passed. Parents can still apply, however all applications received after the 31st October 2020 will be processed as a late application.

Parents are encouraged to apply for a place online via our school admission web pages <u>here</u> which contains a wealth of information including the deadline dates for applications, school catchment areas, deferred entries, making an application on religious/faith grounds and how places are allocated.

If parents have difficulty completing their application, they must contact Admissions before the relevant deadline, as submission after the deadline will mean your application will be processed in the late round.

Parents will be notified of the outcome of their application for a school place for September 2021 on the following days:

SCHOOL ORGANISATION

Up to 43,000 new homes are expected in Central Bedfordshire by 2035. The Council's Schools for the Future Programme has been established to ensure that we plan for the new school places that will be needed in the longer term and ensure that we have them in the right places delivering the best education.

In response to both the forecast demographic growth and the forecast deficit in secondary school places in Houghton Regis, the Council approved the proposal to build a new secondary school on the Kingsland Campus in Houghton Regis (subject to planning), through the 'Free Schools Presumption Process'.

The Head Teacher Board, of the Office of the Regional Schools Commissioner, approved the Council's preferred sponsor – Advantage Schools - for the new school at their meeting on 30 September. Officers are now working with the approved multi academy trust in order to deliver the new school for September 2022, following the closure of Houghton Regis Academy in August 2022. The initial designs for the new school can be viewed on our website here. Officers attended the Houghton Regis Town Partnership Committee meeting in November to present the plans for the school, which are due to be discussed at the CBC Development Management Committee on 13 January 2021. Representatives from the Advantage Schools Trust are due to attend the Houghton Regis Town Partnership Committee meeting in April 2021.



Construction has started in order to expand Thornhill Primary School, Grove Road, Houghton Regis by 60 places in each year group for September 2021, which is also in response to the current and future significant housing development on land north of Houghton Regis, known as HRN1.

7. PUBLIC HEALTH

STOP SMOKING

The delivery of Stop Smoking Services through GP Surgeries continues to been severely impacted by the Coronavirus Pandemic and the latest data, from Q2 20/21 shows that, consistent across the Chiltern Vale sub Cluster B "Titan" locality, both Houghton Regis practices are performing under target.

Overall, performance by the Titan Primary Care Network of Practices in Chiltern Vale was at 40% against target for the period up to Q2 20/21 (19 actual quits compared to a target of 48).

COVID 19 has had an impact on the resources available to deliver stop smoking support in Primary Care and the data reflects the reduced levels of activity:

The Stop Smoking Service delivers flexible support options, including telephone support, plus a new app, which continues to support local residents throughout the pandemic.

Extended treatment programmes are available to some residents who would benefit most from them, for example those with a Mental Health diagnosis or COPD (Chronic Obstructive Pulmonary Disorder). The Smokefree Baby and Me programme is also available for pregnant smokers.

NHS HEALTH CHECKS

The NHS Health Check is a national risk assessment and management programme for those aged 40 to 74 living in England, who do not have an existing vascular disease, and who are not currently being treated for certain risk factors.

It is aimed at preventing heart disease, stroke, diabetes and kidney disease and raising awareness of dementia for those aged 65-74 and includes an alcohol risk assessment. Everyone receiving an NHS Health

Check will have a risk assessment which will look at individual risk factors as well as their risk of having, or developing, vascular disease in the next ten years. An NHS Health Check should be offered every five years.

GP practices continue to be the sole provider of the NHS Health Check programme; however, performance varies. As patients are entitled to one Health Check every five years, Practices have a target to invite 20% of their eligible population each year.

The latest data, collected in December 2020, shows that in all Primary Care settings, including Chiltern Vale, the Coronavirus Pandemic continues to have significant impact on delivery of NHS Health Checks, due to them needing to be delivered face-to-face, with no option for virtual delivery. Only 180 Health Checks were delivered against a target of 1,098 for the period (16.4% of annual target to date). They have invited 560 patients for a Health Check (target 2,956) so are performing at 18.9% for that indicator.

The local Practices are performing as follows:

Houghton Regis Medical Centre is performing at 41.4% for Health Checks delivered (63 against a target of 152) and 22.7% offered (93 out of 410 target).

Wheatfield Road has still yet to offer or deliver any Health Checks during 2020-21.

Data quality Houghton Regis Medical Centre continues to be excellent, above all other CV Practices, at 100%.

COVID continues to present significant disruption to the delivery of Public Health services in Primary Care and will continue to do so as Primary Care Networks are increasingly involved in the organisation and delivery of COVID vaccination programmes. We will continue to work with Practices to identify how we can support them looking to deliver Stop Smoking and Health Check services to their patients.

TIME2CONNECT

Time2connect, continues to engage with local residents and stakeholders.

Time2Connect is being run by Community Action Bedfordshire. It aims to develop the social infrastructure of the area by bringing communities from new developments together with the existing population, encouraging residents to becoming more involved in their communities. In turn, this will

tackle issues like isolation, and improve mental health, wellbeing and self-esteem amongst residents. Community Action Bedfordshire will look at existing community groups and networks within Houghton Regis and build on those to connect residents with resources in the area.

8. PUBLIC PROTECTION

COMPLAINTS

We continue to receive sporadic noise complaints from the Houghton Regis North (HRN) development. These are investigated straight away and we have direct contacts for the site managers across the varying contractors, this enables swift action and resolution.

An off road motorcycle track was operating adjacent to the new homes at HRN, causing a disturbance to residents, however this has now ceased and planning permission obtained for the land to be redeveloped.

COMMERCIAL TEAM UPDATE

The Commercial Team continue to respond to a variety of complaints regarding non-compliance with Covid regulations and restrictions, and requests to advice and guidance from various businesses around the area, not least due to the rapid escalation in our Tier status over the past few weeks and the changes to the rules and guidance.

9. ENVIRONMENTAL SERVICES

LOOKING BACK

As reported in the previous report, Refuse, Recycling and Street Cleansing services will continue throughout lockdown and beyond. It was necessary to prioritise some service areas due to resource availability during the initial stages of the pandemic, however where service provision was suspended or reduced every effort was made to re-instate these at the earliest opportunity.



Grass cutting and shrub bed maintenance continued throughout the lockdown with limited impact on the service provision or standards.

There have been various ad-hoc cleansing and clearing operations. Services have been under greater pressures during the lockdown and continue as residents continue to work from home (where possible) and change social habits/exercise regimes to include use of public spaces more frequently. Cleansing services have adapted to these changed and increased demands and will continue to be reviewed as demand develops.

With the third lockdown service provision will be continually reviewed with our Contractor and should staffing levels begin to be affected by the new variant strain of Covid 19, services may have to be prioritised to reflect this.

NEW FOOD WASTE COLLECTIONS

Following the Council's 2018 waste consultation which revealed that residents were overwhelmingly supportive of recycling and wanted the option to recycle more of their waste Weekly food waste recycling collections in the south of Central Bedfordshire were introduced in November 2020.

All residents (except those living in flats) received a small 23-litre outdoor food waste bin, smaller indoor kitchen caddy and a roll of food waste caddy liners to all houses together with an A5 4-page leaflet explaining how to use the bins and which food items can and can't be included in the collection. If a resident has not received their food waste kit, they can contact the council.

Further communication was provided to residents, Town and Parish Councils, Customer Services and other relevant stakeholders for the duration of the delivery period through a variety of different channels, including a press release, social media and via the council website.

GARDEN WASTE COLLECTIONS

All kerbside garden waste collections are suspended between Monday, 7 December 2020 and Friday, 26 February 2021 inclusive. Collections will resume again on Monday, 1 March 2021.

During the break in service, garden waste can still be recycled at our Household Waste Recycling Centres which are open seven days a week from 9am-5pm, including bank holidays. Certain restrictions due to Covid-19 may be in operation at all four sites.

HWRCs

Household Waste Recycling Centres remain on a booking system which is a simple process of residents booking a slot here:

and taking along proof of booking and CBC residency. This is to ensure safe throughput of visitors on site and to control queuing.



10. SUSTAINABILITY

In September the Council adopted its Sustainability Plan. This sets out the initial course of action and priorities that the Council will aim to follow to support Central Bedfordshire to become net zero carbon as well as realising the wider co-benefits from considering sustainability in all that the council does. A key part of this will involve engagement and working with key stakeholders, such as town and parish councils, businesses and communities. This will be developed over the coming year. A key first step was taken in December when the Council launched its new Central Bedfordshire Tree Planting Fund, aimed at delivering tree and hedge planting schemes across Central Bedfordshire. Town and Parish Council's, local voluntary and community organisations, schools and other groups can apply for funding (or match funding). Projects can vary in size, from a minimum of five trees upwards, to larger areas of new woodland. Planting more trees and hedgerows represents one of the key ways in which the climate challenge can be met. It will help increase biodiversity and mitigate other environmental issues such as flooding and air pollution. In addition to this, it will help create a nicer environment that benefits communities in many ways. 11. TRANSFORMATION

COMMUNITY ENGAGEMENT

COMMUNITY AND VILLAGE HALLS SURVEY

In collaboration with Bedfordshire Rural Communities Charity (BRCC) we are surveying Community and Village Halls in Central Bedfordshire to ensure we have an up to date understanding of their status and any planned improvements. This will help to inform requests for S106 funding, which must be project based, and the Village Halls Advisor at BRCC can support halls in need of help around governance and management of their facilities.

COMMUNITY CHAMPIONS

We have engaged with over 200 residents who signed up to be a Community Champion to assist with the amplification of public health messages to help keep residents safe during the pandemic. We estimate that the Champions help us to reach a further 26,000 residents when they share social media posts and email alerts with their friends, families and social networks. We hold regular drop in sessions to keep in touch with the Champions and listen to their feedback.

Subject to budget approval in February we plan to run the Ward Councillor and Community Asset Grant schemes in 2021/22.

CONSULTATIONS

BUDGET 2021 CONSULTATION

The consultation on the draft budget proposals has started. This process will run until 5pm on 27 January 2021 and has been widely promoted through our digital and conventional communication channels.

The headlines are as follows:

- Next year we anticipate spending some £402million on a full range of services.
- We're also continuing to focus on efficiency with £10.7million of efficiency proposals for next year.
- But we continue to face big increases in demands, particularly in Adult Social Care. We also
 recognise the pressures we face in key areas such as public health, social care and children's
 services (including services for children with special educational needs/disabilities). We will also
 need to focus on economic recovery and supporting job creation.
- To bridge the gap between what we need and what we anticipate in terms of income, we propose to:
 - apply the Adult Social Care Precept of a 3% increase on council tax to contribute towards funding care services, and
 - increase council tax by 1.95% for fund other services.
- Additionally, the consultation will highlight proposals for almost £128million of capital investments, including schools, roads, health and leisure and other infrastructure projects.
