924 IMPROVING HEALTH & WELLBEING IN HOUGHTON REGIS: TIME 2 CONNECT

Gina Croxford, Community Engagement Manager, and Bex McBrearty, Community Connections Advisor of Bedfordshire Rural Communities Charity (BRCC) were not in attendance at the meeting.

925 PLACE DELIVERY UPDATE

Alice Arden Barnatt, Programme Enabling Manager, Place Delivery, was in attendance and provided members with an update on the Kingsland Levelling Up Fund bid.

Members were advised that Central Bedfordshire Council had been successful in gaining grant funding for a new Community and Leisure Centre, the funding criteria preordained it to be spent by March 2024. The new building would be on the existing Houghton Academy site. Members were advised on how the project would be managed and a proposed timescale. Members were advised that there was a commitment to engage with local stakeholder and residents throughout the process via online consultation, drop in events, engagement panel, HR Together Group and key stakeholder groups and leisure centre user groups.

Members welcomed the investment into the town.

926 HOUSING AND ENGAGEMENT

Kim Hopcroft, Housing Operations Manager, Housing Operations and James Yeomans, Head of Housing Property, Housing Services was in attendance to provide an update including All Saints View (ASV), The Brook, and Windsor Drive engagement.

Members were advised it was hoped that phase 1 of ASV would be completed by Christmas, however, there was still much to do. Red house Court residents would be the first to move into ASV in the new year. The demolition of Red House Court would then take place, once demolished work would start on 57 apartments due for completion May 2023. Members were advised there would be function suites available for hire within ASV.

Members were advised of signage that would be on display for ASV.

It was advised that a new website had been launched on 10th November, accompanied with a brochure and PDF. A show apartment would be available to view and leaflets had been distributed and displayed.

Members were advised on services and amenities and travel options available to residents of ASV.

6/23

Members were advised that work on the Brook had been moving on, it was hoped the building would operational late April 2022.

Members raised concerns of the risk factor of the clientele of the Brook and were assured that the users of the facility were of low risk to the community and staff were available on site. It was requested that further community engagement take place, possibly an open day prior to the facility opening, to advise members of the community of how the facility would be run and address any questions they have.

Members were advised that the facility would be managed by Central Bedfordshire Council officers.

Members were advised that Windsor Drive was still in the early stages of the process, it was advised that feedback was still being collated, it was highlighted to members that there remained a high need for affordable housing. The recent listening event held on site had received good interest and was well attended. It was advised that there was a facility to sign up to Windsor Drive updates on the Central Bedfordshire Council website. Members were advised that a definitive decision had not been made at this stage, this was exploration of opportunity. Members were advised that consideration was being given to what facilities can be offered to, and put into, the local community.

Members were advised that other sites in Houghton Regis had been looked at. Members queried the volume of focus on Houghton Regis for housing rather than other local towns given the degree of development already within the town. Members were assured that all areas across Central Bedfordshire were being looked at for potential affordable housing development sites.

Members requested that data be supplied from Central Bedfordshire Council showing statistics of whether residents of the new affordable housing were from Houghton Regis or outside the area.

927 BEDFORD SQUARE COMMUNITY CENTRE

CBC had advised that it was the intention to launch a consultation into the future use of the Community Centre week commencing 11th October. Details of the consultation would be circulated to members of the Partnership Committee as soon as they were available. Members were invited to consider the consultation.

Members were advised that 93 responses had been received, of which 63% were from Houghton Regis residents, feedback was due to go to the Overview and Scrutiny Committee on 27th January 2022 and the forwarded to the Councils Executive on 8th February 2022.

Members queried that the centre had been considered low usage, members were advised that statistics had been looked at for 12 months prior to lockdown, at which time 32% of bookable hours had been booked which left the centre unused for 68%. Members suggested that the lack of use could have been due to the lack of promotion of the facility by Central Bedfordshire Council, additionally the cost of security made the out of hours hiring cost prohibitive for many groups.

Members were advised that the Community Safety Team could be contacted to aid the resolution of any anti-social behaviour in Houghton Regis.

Windsor Drive Open Space

Listening event – 13 November 2021 **Feedback**

A great place to live and work.









Introduction

This document summarises a pre-application engagement event held by Central Bedfordshire Council (CBC) to collect local responses to the proposal of housing development on Windsor Drive, Houghton Regis.

Central Bedfordshire Council determined that an open and transparent engagement event preceding any further site surveys or a formal planning process should be delivered to provide up to date information on the Council's thinking and provide an opportunity for early input. To this end, community consultation specialists BAS Consultancy and Play Disrupt were engaged to lead the process.

The team transcribed conversations and recorded key topics following spoken discussions with participants in addition to collecting data via three creative tasks, as described below.

Creative tasks

a. Current use

To uncover popular as well as less common current uses of Windsor Drive, Play:Disrupt devised an activity which collected a number of different pieces of data:

- Types of activity
- Frequency of activity
- Demographics undertaking activity
- Time of day activity is done

The activity invited participants to represent their activity on a map of Windsor Drive to show routes, spaces and uses. Responses are summarised in the section below.

b. Future use

To engage people with ideas for the future of Windsor Drive, Play:Disrupt created a 'Subbuteo'-style board in the shape of Windsor Drive, reflecting its current common use as a football practice pitch. Around the edge, instead of advertisements, were questions. These questions asked if any improvements were to be made to Windsor Drive in the future, what they might be.

These questions were:

- What do we need for the future of Windsor Drive?
- What facilities?
- What activities?
- What kind of place?
- What's the atmosphere?
- Who is it for?
- What kinds of habitat?
- What must be kept?
- What's missing in Houghton Regis?



The activity was well used and engaged with. The public used flags, plasticine and models to put across their views. Results are described in the Responses section and full feedback is collated in **Appendix 2**.

c. General amenities

Play:Disrupt created a board for stakeholders to record the general facilities and amenities that were lacking in the area or that the area needed less of. These are described in the Responses section of this report below.

Responses

The outcome of the creative tasks and conversations is detailed below.

Current use

Common activities (dog walking, jogging, taking children to play, walking) were prompted but attendees added many more, shown here:

The most frequently described activities were walking (36) and dog walking (19), followed by jogging (9) and taking children to play (9).


Windsor Drive's daytime use is over three times higher than evening and night use which may be partly explained by the lack of lighting. The most popular time to use Windsor Drive is in the afternoon.

Those who use Windsor Drive do so with great frequency, with running and dog walking being mostly daily occurrences.

Full feedback is available in Appendix 1.

Future use

Feedback from the 'Future Use' creative task has been grouped into seven themes:



The most common feedback was to develop nature and recreation on Windsor Drive.

Where recreational development was called for, this commonly fell into one of four categories:

- a. Seating
- b. Paths
- c. Accessibility
- d. Exercise/activity

Common themes around developing nature include: rewilding, planting trees, managing and rejuvenating the brook, wildlife habitat improvement, wildflower sewing, wildlife signage.

Eight responses specified that no housing should be built on Windsor Drive, and an additional thirteen responses specified that nothing at all should be done on Windsor Drive.

Five responses called for new facilities: new daycare centre for special needs adults, more GPs, dentists, doctors, schools, local community shop, mobile coffee shack. Two responses specified certain types of housing provision: bungalows for disabled people and council housing.

General amenities and facilities

In the 'more of' less of' area, doctors' surgeries and greenery/nature were frequently mentioned in the 'more of' category. Also mentioned were floodplains, police presence, and homes sized for those wishing to downsize. In the 'less of' category a common view was to see less housing, housing without infrastructure, traffic and poverty.

Full feedback is available in Appendix 2.

The transcribed conversations reflect the data collected in the above three activities: lack of infrastructure, need for green spaces for mental health, lack of doctors and health provision, antisocial behaviour, need for better access to green space.


Windsor Drive is important to the community intergenerationally, with important life moments taking place there. There is a great deal of love and appreciation for the place, particularly after coronavirus and the close access to green space it provided. At least one person cited the reason for buying their house was the proximity to this green space.

The lack of infrastructure provision (particularly doctors and dentists) was often mentioned. The community feels that a lot of housing has been built in Houghton Regis, but not enough infrastructure provision for those additional residents.


What also became clear during the listening exercise was the lack of trust attendees had in the council, and the belief that the council will go ahead with plans despite any objections raised.

PROJECT UPDATE

Purpose of the To update members on the Tithe Farm Recreation Ground

Report: Sports Project.

1. RECOMMENDATION

This report is provided for information only.

2. BACKGROUND

This project comprises an all-weather pitch, new changing rooms and car parking on Tithe Farm recreation ground. The project is being developed and progressed in partnership with Central Bedfordshire Council (CBC) and the Beds Football Association (Beds FA). Funding for the project is likely to come from the Town Council, CBC and the Football Foundation.

The council has appointed a Bid Consultant and a Design Architect to support the project development.

3. PROJECT SUMMARY

Members are advised of the following:

Land Registry

The application to register the land has been made to the Land Registry (October 2020). There has been recent communication from the Land Registry over this application. This is still very much a work in progress and is proving difficult to progress due to historic conveyances and leases and the number of third parties involved in these. Investigations and options are being considered currently. There is a likelihood that the council will need to source legal advice on this matter.

Planning

The planning application was submitted to CBC late August and has been validated. It is due to be determined just prior to Christmas.

Pitch tenders

Members were previously advised that the contract has been awarded to Field Turf. The contract price is £761,334.12

The pitch tender included the car park extension and refurbishment as an extra cost. The cost for this is an extra £106,512.35. However there remains a little uncertainly over this element as drainage of the new pavilion is currently being considered. The Committee are not being asked at present to consider the car park works as it is tied in with the tender price for the pavilion and outcomes of drainage surveys.

Pavilion tender

The tender process ran during October and is currently open. The tender process will be managed in accordance with the Council's Financial Regulations. Once tenders have been received back it is likely that a special meeting of the Environment & Leisure Committee will be called to consider the tenders and award the contract.

The new pavilion will be established based on design and build. At this stage it is possible for the building to be heated using gas or a ground source heat pump. There are financial and environmental issues around both options. Members will be asked to consider this is due course.

VAT Position

Members are advised that VAT advice has been sourced. This is attached for consideration.

4. PROJECT FUNDING

Please refer to Appendix A.

This is still a provisional funding outline as the tender process for the pavilion has not concluded to date.

5. PROJECT TIMELINE

Please refer to Appendix B.

Members are advised that this timeline has scope to be moved as there remain some significant variables on this project which may have an impact on whether the project is fit to be considered by the Football Foundation in January 2022. These variables are:

- Conclusion of the Land Registry process
- Award of the contract for the pavilion build
- Securing of planning permission

6. FUTURE CONSIDERATIONS

It had been hoped that this report would present for consideration a number of significant recommendations relating to this project. However due to delays associated with the Land Registry process and with the pavilion tender process this has not been possible.

It is anticipated that a special meeting will be called in the coming weeks. At this meeting members will be asked to consider the following:

- 1. Confirmation of pavilion design (whether it will include the community space)
- 2. Award of pavilion contract
- 3. Confirmation of project funding including:
 - Use of ear marked reserves
 - Requirement for borrowing with a referral to Town Council as necessary
- 4. Future site management

2. LEISURE, LIBRARIES & COUNTRYSIDE

Chalk Pit

Work is ongoing to prepare a legally binding funding agreement with the Wildlife Trust and the owners of the Chalk pit have notified CBC of the transfer of responsibility of the site to the Council to which Legal have initially suggested that a more formal process should be followed. We cannot issue a licence or a lease as we don't own the site.

In the meantime we are liaising with the WT to see if we can develop a new management plan to be agreed by us and Natural England which will form part of the Funding Agreement.

HOUGHTON REGIS LIBRARY

Over the Christmas period we ran Christmas crafts for young people, to either make in the library or take away, which were very well attended. We had successfully resumed two of our weekly Children's activities before this, however they are now on hold until after the February half-term.

Staffing has been affected by covid outbreaks over the past month, but despite this we've been incredibly busy. We are giving out the new LFD's and now have the Pop-up Vaccination centre open until Sunday 23rd January. We're really hoping there will be a decent uptake for this.

HOUGHTON REGIS LEISURE CENTRE

The centre is open, with Covid safe procedures in place including additional cleaning. Usage at the centre continues to grow as customer confidence improves. The site sales team is undertaking outreach work within the community to improve awareness of the centre's existence and has made positive links with the sales teams at the new home sites in the area to ensure that residents new to the area are made aware of the centre as soon as they arrive in Houghton Regis. News of the New Facility is now in the public domain and SLL will be showing support to the planning process and assisting with the public awareness throughout the community.

HOUGHTON HALL PARK

Another successful festive season in the park with several popular community events being held, including wreath making sessions, reindeer trail with Santa, and Spirit of Christmas outdoor performance. The volunteer group is developing further as the Friends of Houghton Hall Park and will be fully constituted later this year.

In March 2022 we will reach the end of the National Lottery Heritage Funded 'Parks for People' project including submission of a final evaluation covering how the aims of the project have been delivered. Aims for the next couple of months are to submit the application for the Green Flag accreditation, undertake some maintenance and upgrade works to paths in the park, and planting of some tree whips in the woodland. The team are busy working on events and engagement for Mother's Day and Easter.

ACTIVE LIFESTYLES

COMMUNITY PHYSICAL ACTIVITY OCTOBER 2021 – DECEMBER 2021

The Active Lifestyles Referral programme is continuing to run. The service was adapted, and support was given to those who were currently on the programme including more individual calls to support personal wellbeing. 3. BUSINESS, INVESTMENT, EMPLOYMENT & SKILLS

The Council's Business and Investment team continue to deliver the Additional Restrictions Grant wider business support programmes, which can still be accessed up until the end of **March 2022**.

These wider business grants include:

- Bedfordshire Chamber of Commerce: provide free International Markets support
- Cranfield University: businesses can access a number of <u>projects</u> including the Net Zero Top-up,
 Business Growth Programme, Essential Management and Finance Fundamentals to enable them to
 grow
- SEMLEP: The <u>Business Support and Mentoring Programme</u> can provide advice and guidance/grant
- University of Bedfordshire, Central Bedfordshire Productivity Programme: provide bespoke
 productivity training and specialist consultancy support, which offers two courses <u>Lean Thinking and</u>
 <u>Lean Six Sigma Green Belt</u>.

Additional Council funding has allowed for the **Green Business Network** to:

- Encourage businesses to work towards being net zero carbon, and to become new Members
- Provide an innovative green referral networking group to create a region-wide green supply chain of companies referring each other's green solutions.

COVID-19 BUSINESS SUPPORT GRANTS

On Wednesday 15 December, the Government published guidance for its Covid-19 Additional Relief Fund (CARF) providing additional business rates relief. The Government has allocated us over £5.3 million and we are working through the detail to understand the number of businesses we can support, in which sectors and how much they will receive.

On Tuesday 21 December, the Government announced further funding for businesses in the hospitality and leisure sectors most affected by the Omicron variant. We are waiting for further information from Government on the distribution of the Omicron Hospitality and Leisure Grant (OHLG) and as soon as this is available, we will distribute funding to eligible businesses.

For the period 1 Sept – 1 Dec, there were 47 new property enquiries across Central Bedfordshire, 18 of which were interested in Houghton Regis/Dunstable – please see table below. This represents a doubling of enquiries interested in Houghton Regis/Dunstable in comparison to the previous reporting period. Logistics and small retail companies account for 50% of these enquiries. Progress with fitting out of the UPS building is moving on a pace and construction of both Amazon and Lidl are due for completion later

this year. We are in contact with Ocado and hope to have further information regarding the type of operation and expected timescales for their new distribution centre at J11a, M1.



BEDFORDSHIRE EMPLOYMENT & SKILLS SERVICE (BESS)

The lockdowns which have occurred over the past (almost) two years have meant that the Council's Employment and Skills Service (BESS) and its partner training providers have delivered most of its adult learning classes during that time online. Where community based classrooms have opened (on a limited basis) they are doing so with strict Covid-19 safety restrictions in place and a requirement for learners and staff to take lateral flow tests and provide evidence of a negative result. Whilst the move to online learning has enabled many residents to undertake courses who might not otherwise have had the time or resource to travel to a classroom, we are aware that online learning isn't accessible to everyone and look forward to delivering more face to face, community based learning in the future.

In the current academic year, which started in August 2021, we have engaged with 36 Houghton Regis residents to date, ten of whom were unemployed when starting their learning with us. The most popular courses were Getting Started with English and Maths, ICT, Early Years, and Supporting Teaching and

Learning. The figures also include three individuals undertaking apprenticeships in Early Years Educator, Adult Care and Business Administration.

BESS has a number of courses and workshops which are designed to help and support unemployed residents into work. Programmes can be quite generic, offering information and advice on changing career or how to tailor a CV to a specific job role. Some courses are sector specific, working closely with employers who are seeking to recruit or which can lead into fully mapped career pathways. BESS has a close relationship with DWP and, together with its partners and where our Government funding allows, can deliver bespoke courses specifically requested by stakeholders supporting Central Bedfordshire residents. Its in-house team of advisers can also offer 1 to 1 support to residents on finding employment or changing career.

The BESS curriculum includes courses for the following:

- English
- ESOL (English for Speakers of Other Languages)
- Maths
- IT and digital skills
- Support with wellbeing and mental health
- Preparing for employment
- Working with and supporting children and young people
- Health and Social Care
- Apprenticeships

A list of workshops and courses with information and how to enrol can be seen by looking at our <u>upcoming course list</u>, with an overview of the workshops and courses available on the <u>curriculum map</u>. In November 2020 the vacancy rate for all units within towns surveyed was 7.3%, there were a total of 957 units of which 70 were vacant. A year later in November 2021 the vacancy rate fell slightly to 7.0% with a total of 966 Units and 68 vacancies. Since last quarters survey, some increases in vacant units have been seen in Dunstable and some decreases can be seen in Stotfold, the rest remain unchanged or relatively stable.

ADMISSIONS UPDATE

The closing date for applications for Starting School and Transfer to Middle School was 15th January 2022.

Admissions has worked closely with the local authority's communications team to encourage applications and for parents and guardians to apply on time, to increase their chance of obtaining a place at their preference school. On a regular basis the team has pushed the message on Facebook and Twitter. This in conjunction with the Admissions Team working with schools to remind parents/ guardians to apply on time and frequent chaser letters has helped to increase the level of on time applications.

In regard to Upper and transfer to Secondary school applications (closing date was the 31 October 2021), parents who applied on time will be notified of the outcome of their application on the national offer day on 1st March 2022.

6. PUBLIC HEALTH

COVID-19

Public Health continues to lead on outbreak management and control in relation to the Pandemic, in partnership with lots of other CBC Teams.

Following the arrival of the Omicron Variant, we have seen cases rise significantly across Central Bedfordshire, so it remains important that we continue to follow the COVID guidelines, ensuring social distancing, hand hygiene, wearing face coverings and maintaining good air flow/ventilation through internal spaces where possible, as well as following the other rules, as they change. STOP SMOKING

The delivery of Stop Smoking Services through GP Surgeries continues to have been severely reduced, with direct and indirect impacts from the Coronavirus Pandemic. Due to delays in National reporting there is currently no update performance data available.

The Stop Smoking Service delivers flexible support options, including telephone support, plus a new app, which continues to support local residents throughout the pandemic.

The service was looking to recommence face-to-face support, particularly for the most vulnerable clients, but this has been put on hold due to the Omicron Variant.

A Service Review is underway to look at how the Service can increase and improve its offer for local residents, whilst acknowledging the fact that most smokers, as identified by recent customer insights work, still see Primary Care as the main route into Stop Smoking Services.



Extended treatment programmes are available to some residents who would benefit most from them, for example those with a Mental Health diagnosis or COPD (Chronic Obstructive Pulmonary Disorder). The Smokefree Baby and Me programme is also available for pregnant smokers.

NHS HEALTH CHECKS

The NHS Health Check is a national risk assessment and management programme for those aged 40 to 74 living in England, who do not have an existing vascular disease, and who are not currently being treated for certain risk factors.

It is aimed at preventing heart disease, stroke, diabetes and kidney disease and raising awareness of dementia for those aged 65-74 and includes an alcohol risk assessment. Everyone receiving an NHS Health Check will have a risk assessment which will look at individual risk factors as well as their risk of having, or developing, vascular disease in the next ten years. An NHS Health Check should be offered every five years.

GP practices continue to be the sole provider of the NHS Health Check programme; however, performance varies. As patients are entitled to one Health Check every five years, Practices have a target to invite 20% of their eligible population each year.

The latest data, collected for April-December 2021-22, shows that Primary Care settings Chiltern Vale have re-introduced the delivery of Health Checks, despite the Coronavirus Pandemic. In Chiltern Vale already 783 Health Checks were delivered against a year-to-date target of 693, exceeding that period target. They have invited 2,243 patients for a Health Check (target 3,444) so are performing at 65% for that indicator in the year-to-date.

Data quality score is 77.5% (red) which is lower than the CCG average (83.6%) and needs some investigation.

COVID continues to present significant disruption to the delivery of Public Health services in Primary Care and will continue to do so as Primary Care Networks are increasingly involved in the organisation and delivery of COVID vaccination programmes. We will continue to work with Practices to identify how we can support them looking to deliver Stop Smoking and Health Check services to their patients.

TIME2CONNECT

Time2connect, continues to engage with local residents and stakeholders.

Time2Connect is now being managed by Bedfordshire Rural Communities Charity (BRCC). Project activities continue to develop, building connections across the existing and new communities of Houghton Regis. Ongoing COVID restrictions mean that they have not been able to undertake as much face-to-face work as they would have liked, across the area, in order to increase profile and connections across the area.

LOOKING BACK

As reported in the previous report, Refuse, Recycling and Street Cleansing services have continued throughout the most recent impact of the pandemic and over the Christmas period.

Accumulation of waste remains increased in general; these are identified, inspected, and are dealt with as soon as possible.

HOUSEHOLD WASTE RECYCLING CENTRES – The requirement for resident booking was removed in September 2021 and the sites managed well over the Christmas period.
